



## Florida Leather & Fetish Pride, Inc.

### Event Vendor Contract.

The parties in this contract are Florida Leather & Fetish Pride event, (hereinafter referred to as (“FLFP”) and \_\_\_\_\_ (“hereinafter referred to as the “Vendor ”).

FLFP event is on the following dates:

Vending Room Hours

November 10, 2017 - 7:30 pm – 3 am

6 pm - Midnight

November 11, 2017 - 10 am – 3 am

10 am – 7:30 pm

November 12, 2017 - 10 am – 2 pm

Vending room will open at 10 am. However, all vendors must be ‘moved out’ by 4 pm.

Vendor desires to vend \_\_\_\_\_ at and during FLFP weekend and shall have paid the host the appropriate fee to sell merchandize at the event:

All parties agree to the following:

1. FLFP will provide an 8’ x 10’ indoor vending area to include an 8’ x 10’ table and 2 chairs. Vendor is responsible for providing their own extension cords and lighting if they purchased a vending space with electric. They are also responsible for their own way of accepting credit cards. FLFP does not provide Internet access. The host location offers free Wi-Fi where available, but is not responsible for vendor’s connection.
2. No Vendor shall sell any goods or services other than those described herein at and during the event without FLFP’s written consent.
3. **Vendor may ‘move-in’ as early as 10 am on Friday** to their assigned location for purpose of setting up their vending station, goods, and other things necessary and reasonable to vend at FLFP event.
4. Vendor shall have access to the location for up to two hours after the event’s conclusion to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and in the condition it was before Vendor occupied. **Vendor must be ‘moved out’ by 4 pm on Sunday** or they may be responsible for an additional fee from the hotel.
5. Vending area shall be locked during non-vending hours.
6. Vendor and vendor’s staff shall follow the State of Florida, Pinellas County, and City of St. Petersburg nudity laws in regards to clothing and appearance.

7. No loud music, noise, or sound amplification devices shall be used by Vendor or vendor's staff at the vending location.
8. Vendor is responsible for any legalities pertaining to the right to sell their merchandise in the State of Florida, Pinellas County, and the City of St. Petersburg. This includes, but is not limited to, state licensing fees, permits, etc., and all tax liabilities are the sole responsibility of the Vendor.
9. Vendor is responsible for any damage they may have caused while participating in the FLFP event.
10. FLFP and/or the event location is not liable for any loss or damage and will not be responsible for any personal injury to the Vendor, their associates, or their merchandise. The Vendor hereby agrees to indemnify, to hold harmless, and defend FLFP and/or the event location against any damages or claims that might arise in connection with the Vendor's presence at the event. The Vendor also agrees to indemnify and hold harmless from any acts or omission to the acts of the Vendor, its employees, agents, and assigns.
11. Termination of this agreement by the undersigned Vendor results in FLFP retaining 100% of the Vendor's payment. Payments described will be retained as liquidated damages and there will be **no refunds**.
